Merrion Oil & Gas proposes to use the lined drill pit on location for temporary produced water storage. Water will be trucked offsite to an approved SWD facility for disposal. The Flush No. 1 SWD has been drilled, and we are working on the completion and the injection facility design and construction. The Merrion SWD well should be in operation in about six months. A holding tank will be installed and the drill pit will be closed at that time. We propose to cease discharge to the drill pit at the subject well by July 1, 2001.
