Plug down @ 16:20 hours. Circulate 4 bbls to surface. Drilled 6-1/4 hole to 1342' KB. TD reached @ 7:00 AM on March 2, 2002. Ran Halliburton Spectral Density Evr Processed Log & High Induction Log. Ran 32-jts, 4-1/2", 11.6#, N-80 casing set @ 1348' KB. Cemented w/165 sx 65/35 Std POZ 6% gel, 2% CC lead cement, 10# 1.9 yield 12.4#. Tail in 75 sx 50/50 Std POZ. 1.32 yield, 13.5# slurry, 2% gel, 3# gilsonite, .5% Halide-9, 2% CFR-3. Drop plug @ 1000#. Circulate 30 bbls cement to surface. Rig down cementers. Set slips. Cut off casing. Release rig. Install wellhead. R/U Halliburton and perf from 1164 to 1198' KB w/4 SPF. Frac w/1000 gallons Formic Acid, 4,250 40/70 Brady Sand, 75,000 # 20/40 Brady sand, 694 gallon flush. ISIP - 1260. AIR - 60.9. ATP -2364.
