6/26/02-6/27/02: TIH w/78 jts 7", 20 #/ft, J-55, ST&C intermediate csg to 3,451.43'. Cmt'd csg w/250 sx Type III cmt w/3% extender, 2% gel, 2% Phenoseal (LCM) & 1/4 #/sx cello (mixed @ 11.4 ppg & 2.94 cuft/sx) followed by 150 sx Type III cmt w/1% CaCl2 (mixed @ 14.5 ppg & 1.40 cuft/sx). Circ 44 bbls cmt to surf. PT BOP's to 250/2,000 psig for 30 minutes. Held OK. PT 7" csg to 2,000 psig for 30 minutes. Held OK.
