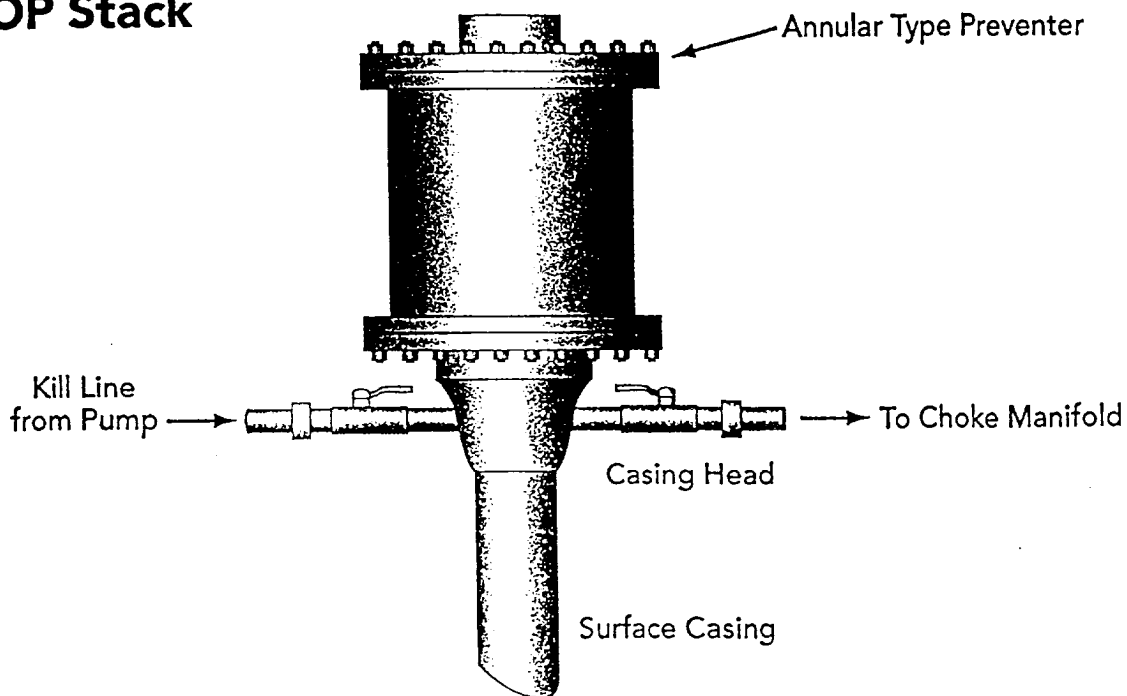


Well Control Equipment Schematic for 2M Service
