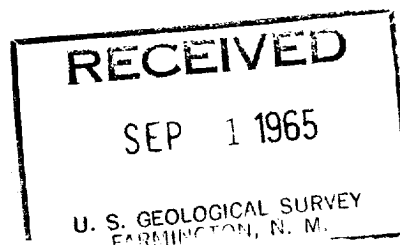

On 8-20-65 total depth 6590'. Ran 2020 joints of 7" and 5 1/2" casing (6578') set at 6590'. Top 8 joints 7", 32#, S-95 casing (314'), bottom 194 joints 5 1/2", 15.50#, J-55 (6280'). Stage tools at 4356' and 2060'. Cemented first stage with 415 cu. ft. 1:1 Pozmix "S" and Class "A" cement, 1/4# Flocele/cu. ft. Second stage would not open. Perforated 4 holes at 4356', cemented w/250 cu. ft. 2:1 Pozmix and Class "C" cement, 1/4# Flocele and 1/4 cu. ft. Strata-Crete "6"/cu. ft. W.O.C. 4 hours for third stage. Cemented third stage w/250 cu. ft. 2:1 Diamix "S" and Class "C" cement, 1/4# Flocele, 1/4 cu. ft. Strata-Crete/cu. ft.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
