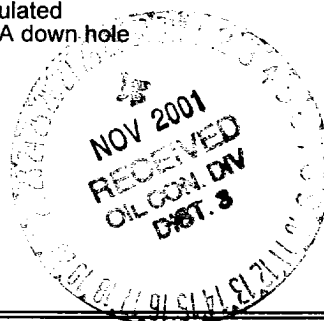

It is intended to add Lewis pay to the existing Mesaverde formation of the subject well by placing a cast iron bridge plug above the existing perforations. The well will be perforated, stimulated and cleaned out to plug back total depth. The well will then be down hole commingled. A down hole commingle application will be submitted.
