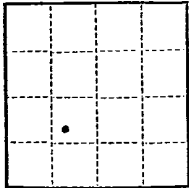

**DETAILS OF WORK**

It is intended to drill a well with rotary tools through the Mesaverde, drilling the pay with gas circulation, and to shoot the entire Mesaverde with two quarts of S.N.G. per foot. Total depth 6740'.

**Casing Program:**

9-5/8" at 160' with 125 sacks of regular cement circulated to surface.  
7" at 6145' with 300 sacks of regular cement.

The W<sup>1</sup>/<sub>3</sub> of Section 17 is dedicated to this well.
