Range 6 West, Rio Arriba County, New Mexico, and in support thereof states the following facts:

- The San Juan 28-6 #12 well, located 1090 feet from the South line and 1650 feet from the West line of Section 7, Township 28 North, Range 6 West, was completed as a gas well on September 19, 1954, and connected to El Paso Natural Gas Company's gathering system December 8, 1954.
- 2. That the proposed non-standard gas proration unit consists of 260.40 acres which are contiguous quarter-quarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


