On 9-18-67 T. D. 4472'. Ran 138 joints 7", 20#, J-55 casing (4450') set at 4472' w/150 sacks of cement. W.O.C. 12 hours, tested w/1200#/30 Min. O. K.

On 9-25-67 T. D. 8651'. Ran 269 joints 4 1/2", 11.6 & 10.5#, J-55 casing (8641') set at 8651' w/440 sacks of cement. W.O.C. 18 hours.

On 9-26-67 P.B.T.D. 8612'. Tested casing to 4000# O. K. Spotted 500 gal. 7 1/2% HCL. Perf. 8502-18, 8554-60, 8572-80, 8592-8600' w/2 SPT. Frac w/40,000# sand, 40,060 gal. water. Max. pr. 4000#, BDP 1900#, tr. pr. 3000-3050-3400#. I.R. 48 BPM. Dropped 1 set of 32 balls, flushed w/6040 gal. water. ISIP 1700#, 5 Min. 1400#, 30 Min. 900#. Set BP @ 8445', tested w/4000# O. K. Spotted 500 gal. 7 1/2% HCL. Perf. 8404-18' w/4 SPT. Frac w/30,000# sand, 30,010 gal. water. Max. pr. 4000#, BDP 1600#, tr. pr. 3400-3500-3700#. I.R. 42 BPM. Flushed w/5700 gal. water. ISIP 2300#, 5 Min. 2200#, 15 Min. 1850#.
