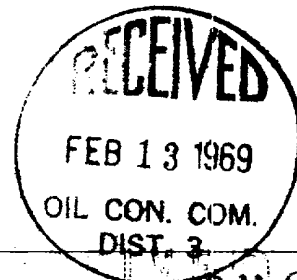

On 12-8-68 spudded well, drilled surface hole.

On 12-9-68 ran 7 joints 9 5/8", 32.30%, H-40 surface casing (219') set at 232' w/150 sacks of cement circulated to surface. W.O.C. 12 hours, tested w/600#/30 Min. C. K.

On 12-19-68 T.L. 4548', ran 144 joints 7", 20%, J-55 intermediate casing (4530') set at 4548' w/125 sacks of cement. W.O.C. 12 hours, tested w/600#/30 Min. C. K.

On 1-21-69 T.L. 8730', ran 271 joints 4 1/2", 11.6% and 10.5%, J-55 production casing (8748') set at 8730'. Float collar set at 8735', second stage tool at 6832', cemented first stage w/100 sacks of cement, second stage w/205 sacks of cement.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
