Cross Timbers Operating Company discovered and isolated a casing leak from 1,086 - 1,676' during a routine workover operation. CTOC proposes to repair this well in the following manner:

1. Set RBP @ 1,700' & cap w/15' sd.
2. TIH w/tbg & spot cement fr/1,685' - 1,080'.
3. PUH w/tbg to 1,000'. Pmp cmt dwn tbg & est circ out bradenhead.
4. Once cement is circ to surf, close bradenhead valve and sqz csg to 1,500 psig.
5. WOC. DO cmt & press tst csg to 500 psig.
6. Re-sqz csg lk if necessary.
7. TIH & CO sd. Pull RBP.
8. RWTP.
