Cross Timbers Operating Company has completed workover operations on the above mentioned well. While on the well the following operations occurred as indicated. On 9-12-98, tubing was lowered into the well to check for fill and then removed from the well and inspected. The tubing was then reran back into the well and landed at a depth of 4,313' KB. On 9-15-98, a downhole pump, new sucker rods and a Bethlehem C57-11.7-42 pumping unit with motor were installed. On 9-17-98, the pumping unit was started and the well was returned to production.
