of 3650' on 11/25/94. Set 5.5" 17# N-80 production

casing at 3647'. Cemented with 525sx C1 B. tail 110sx C1 B. pump 100sx C1 B Cmt Cap.

Circulated 21 BBLS good cement to the surface. Rig released at 18:00 hrs. on 11/25/94
