1. MIRU PU.
2. TIH & CO well to PBTD @ 4,750'.
3. Run GR/CCL/CNL log from PBTD - 3,000'. Set CIBP @ 4,500' w/5 sx cmt cap.
4. Perforate, acidize and sand frac the Pictured Cliffs formation.
5. CO sand to PBTD if needed.
6. TIH w/2-3/8" production string.
7. Swab well to flowing and test.
