11/07/00 - Run 6 joints of 7" (20#, J-55) casing, set shoe at 260'. Cement with 75 sk Type III cement. Displaced with 9 bbls freshwater, returned 7 bbls to surface. Bumped plug with 127# psi at 4:30 pm. Floats held.

11/13/00 - Run 81 joints of 4-1/2" (10.5#, J-55) casing, set shoe at 3470'. Cement with 294 sk 65/35 cement with 6% Gel, 10 pps CSE, 2% CD-32, 0.25 pps Cello Flake and 0.65% FL-32. Displaced with 55 bbls KCl (@5), no returns to surface. Estimated top of concrete is 380'. Bumped plug with 1465# psi at 4:10 pm. Floats held.
