Propose to repair casing leak as follows:

Rig up workover unit, pull 1-1/2" tbg. GIH w/cast iron bridge plug on tbg set @ 6200'. Load hole & test tbg, POH. Pick up packer, GIH w/tbg & find csg leak. Squeeze hole w/ csg w/350 sx cement, WOC.

11 out cement, test csg to 2000#; if any leaks, re-squeeze. Drill out cast iron bridge plug, CO to T.D. POH, go back in hole w/tbg open-ended w/bar collar on bottom.

Swab well off & release rig.
