DETAILS OF WORK

Ran 96 joints of 5-9/16" L.W. Line Pipe with ST&C 14.65# (2300') set at 2305' with 100 sacks regular cement. Weather prohibited temperature survey. Drilled plug and bailed hole dry for one hour - stayed dry.

Held 750# for 48 hours.
