Squeezed plug over Gallup zone, 20 sacks, 5210 to 4975', shot off 4 1/2" csg at 12h2', placed 40 sx, plug 12h2' to 1000'. Placed 20 sacks, plug btm surface pipe 320' to 270'. Placed 40 sacks, plug 90' to surface. Set 4" pipe marker. Well abandoned.
