Marathon Oil Co is proposing to reenter this Plugged and Abandoned well. The proposed procedure is summarized below.

Build and improve old surface location. Install and test safety anchors. Dig out well around dryhole marker. Hot tap 9 5/8" surf casing. Weld casing extension and wellhead on 9 5/8" casing.

MRU PU. Spear 5 1/2" casing and set slips. NU BOP and test to 1000 PSI. Drill out plugs and clean out to 1700' KB. Test casing to 1000 PSI before drilling out past 5 1/2" shoe @ 1637'. Stimulate open hole section 1637-1700' W/approximately 154,000# sand and 30,000 gallons gel. Flow back frac to test tank. C/O to PBTD of 1700'. Install production Tbg to + 1650'. ND BOP. NU Wellhead RDMO PU.

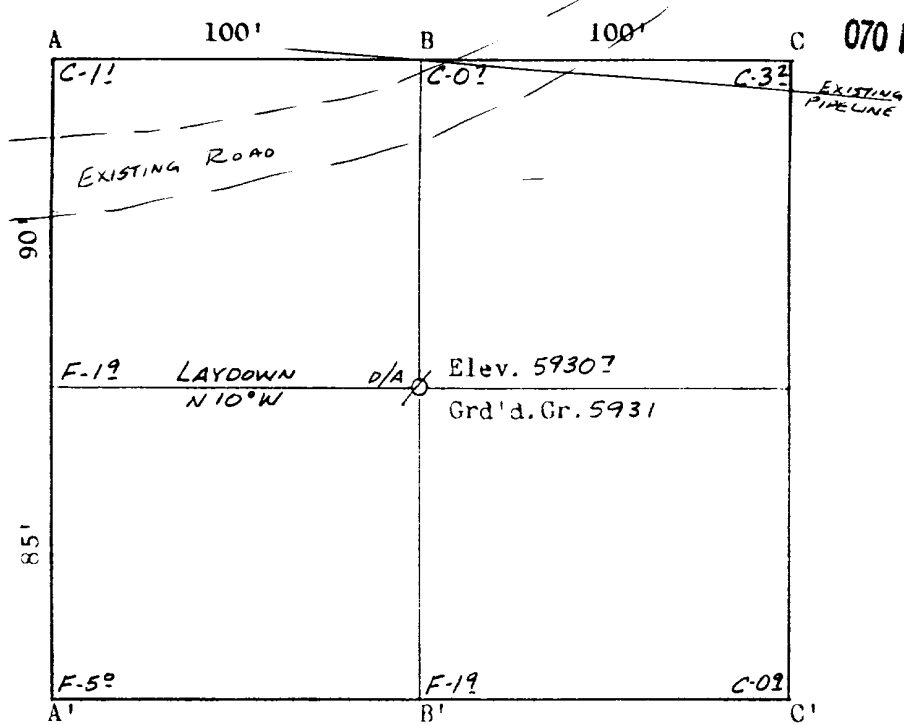

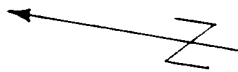

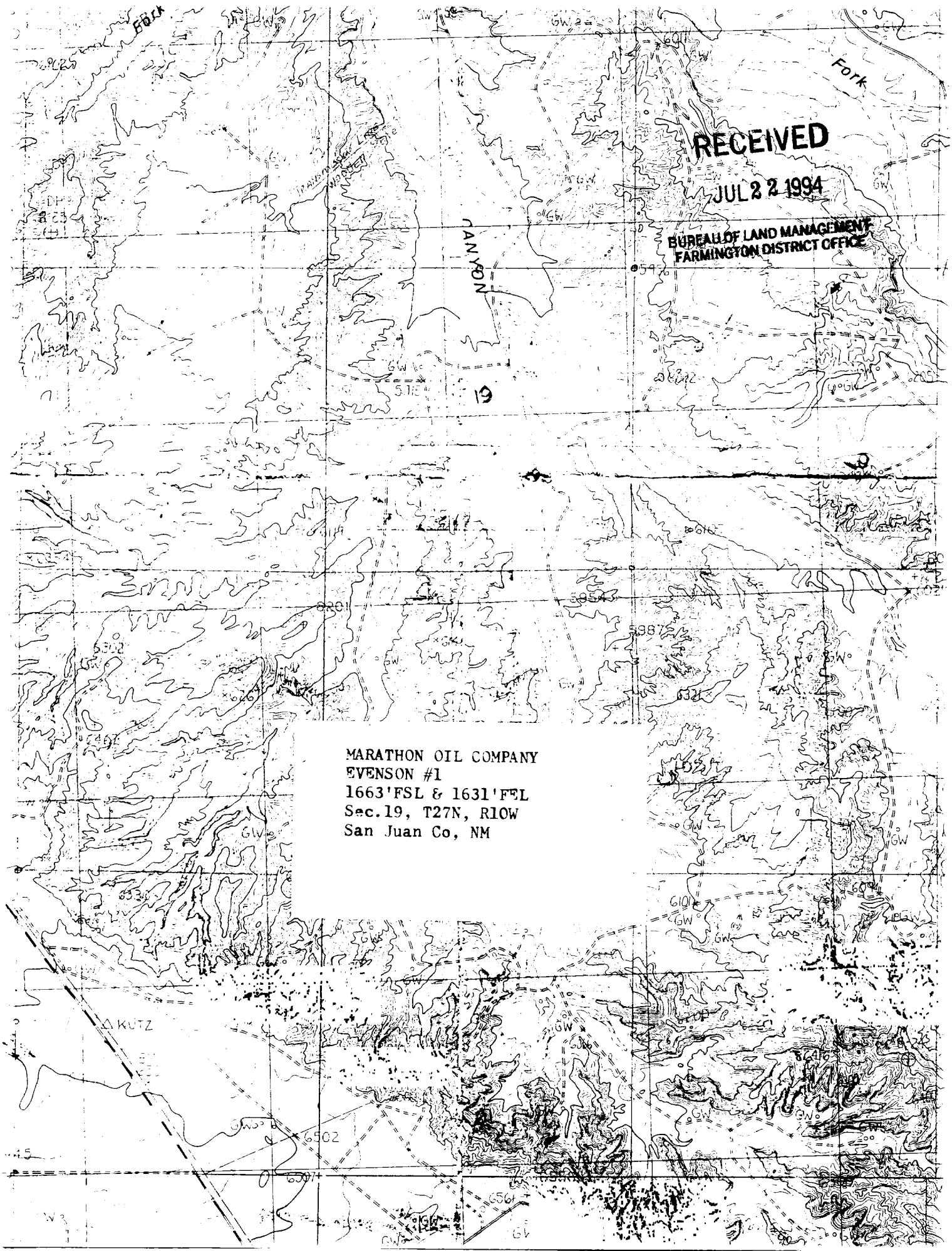
