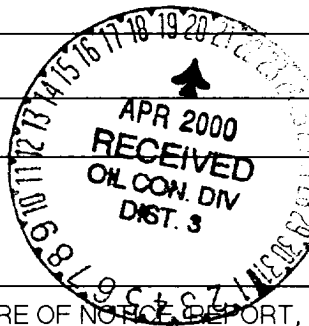

It is intended to deepen, case, and refrac this well as follows:

1. MIRU. TOH and lay down 1" tubing.
2. TIH with bit. Deepen well to 2100'. TOH.
3. Run 3 1/2" 9.3# tubing set at 2100'. Cement to surface.
4. Selectively perforate PC and fracture treat.
5. Clean out to PBD. Land 1 1/2" tubing at bottom perforation. Return to production.
