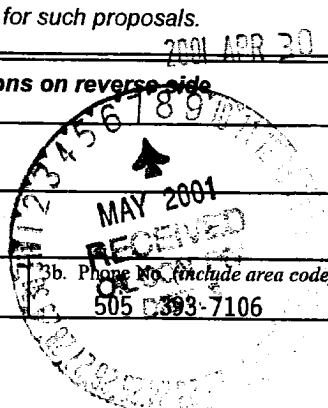

The Bolack No. 2 was recently eliminated from our workover list this year pending further study. However, the wellbore still has significant upside as a coal infill well when the coal is downspaced. For this reason, Marathon would like to TA the wellbore at this time. The TA will be completed by December 2001. Marathon can not complete this work until the irrigating pivots are turned off in the NAPI area. This well is in the middle of an irrigated field. A notice will be sent when the work is complete.
