Dear Sir:

I am returning the acreage dedication plats which you submitted on February 1, 1961, along with a copy of my original letter of December 21, 1960. We already have in our files a plat showing 152.56 acres. The purpose of my letter was to inquire whether or not you wished to dedicate a full half-section unit to this well in order to increase your allowable. As it now stands, with a 152.56-acre unit your acreage factor will be .48, meaning that your allowable is approximately cut in half because of the short acreage factor.

If you own another quarter in this section I would suggest that it be dedicated to this well.

We are returning your plats for this purpose.

1. *Phragmites australis* (Cav.) Trin. ex Steud.

1. *Chlorophyll a* and *Chlorophyll b* were determined by the method of Lichtenthal and Whistler (1973).

1.
