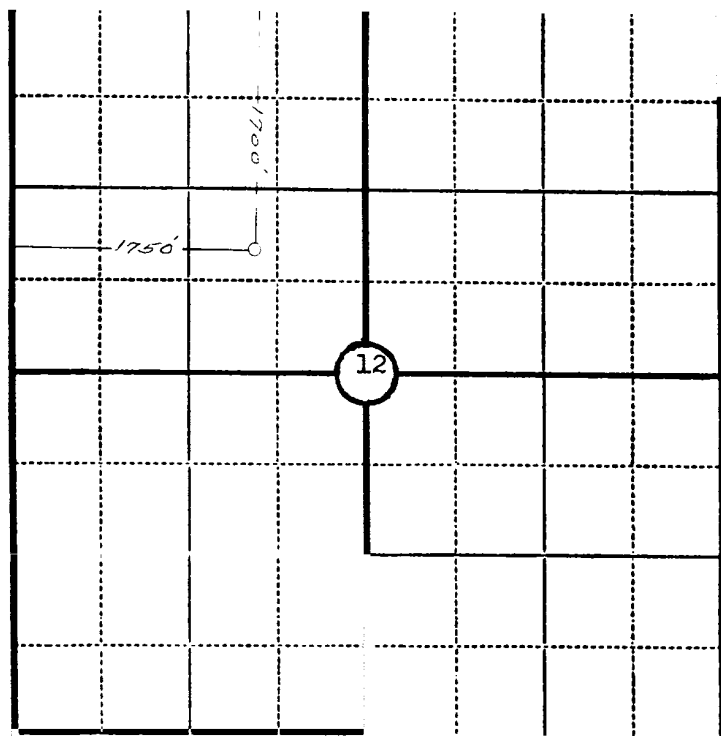
Lease Charley-Pah Well No. 2
