In accordance w/Wayne Townsend w/BLM, shot 2 squeeze holes @ 707'. Pumped 20 sks. Cl. B @ 3 bpm @ 800#. WOC. Tag TOC @ 675'. Shot 2 squeeze holes @ 143'. Pump 20 sks. cement through 1" tbg. to fill 2 7/8" from 675' to surface. Bull-Head 35 sks., cement down 2 7/8" cover 5 1/2" to surface. All procedures witnessed by Joe Sanchez of the BLM.

Set dry hole marker 4' underground as requested by Daniel Lopez, operation manager of NAPI. Surface restored.
