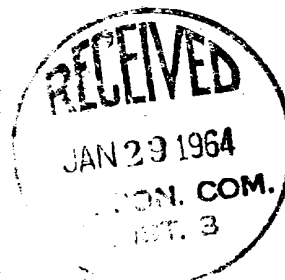

On 1-22-64 loaded hole w/1% calcium chloride water, spotted 250 gallons 10% acetic acid, tested casing w/3800#. Perf. Dakota 6638-43 w/4 SPF; 6700-10, 6721-11, 6808-16 w/2 SPF. Fractured w/67,830 gallons water, 7# J-2/1000 gal., 60,000# 40/60 sand, flushed w/6930 gallons water. I.R. 45.4 BPM, Max. pr. 3500#, BDP 2300#, tr. pr. 1950-2500-3500#. Dropped 3 sets of 20 balls. ISIP 1200#, 5 Min. SIP 1100#, 15 Min. SIP 1000#. Set bridge plug at 6200', tested casing w/3800#. Perf. Mesa Verde 4605-21' w/1 SPF; 4640-44, 4658-62 w/4 SPF, fractured w/43,706 gallons water. I.R. 64 BPM, Max. pr. 3800#, BDP 1400#, tr. pr. 1500-2200#. Dropped 2 sets of 16 balls each. ISIP 200#, 5 Min. SIP 50#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
