MIRU PU.

ND wellhead. NU BOP. POOH w/ 1.9" tbg.

Pick up 2-3/8" tbg and packer. TIH.

Set packer at 1750'. Test CIBP at 1770' and annulus.

If annulus holds, then POOH w/ packer.

TIH w/ CIBP and set at 1750'. Test to 500 psi.

If annulus does not holds, PUH w/ pkr and find leak.

POOH laying down 2-3/8" tbg.

ND BOP. NU wellhead. RDMO PU.

If we can not T&A with 2nd CIBP then we will need to write AFE and obtain WIO approval to fix leak. After fixing leak will T&A until shallower horizons are evaluated latter next year.
