DETAILS OF WORK

We propose to drill this well with rotary tools to an estimated depth of 1381' to the top of the Dakota formation - Approximately 1381' of 5 1/2" O.D. casing will be run and cemented to surface. We will then drill out from under the 5 1/2" casing with cable tools and complete the well open hole.


