3-25-99 TIH w/pkr, set @ 4365'. Reverse circ tbg. PT CIBP to 3600 psi, OK. PT csg to 500 psi, OK. Reset pkr @ 4450'. Pump 300 gal 15% HCl. TOO H w/pkr. TIH, ran CBL @ 0-4470', TOC on 4 1/2" csg @ 4050' w/cmt around DV tool @ 1990-2300'. TOO H. TIH w/3 7/8" bit to CIBP. Circ hole clean. SDON.
