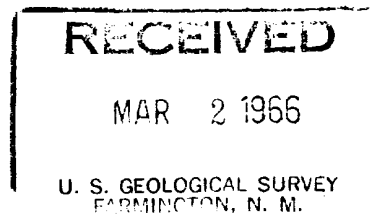

Instructions
