Amoco proposed to plug and abandon the subject well on June 16, 1994 which was approved by the BLM on June 27, 1994. Amoco notified the BLM on September 30, 1994 that it wanted to cancel our request for plug and abandonment but has no record of BLM authorization to cancel. The above referenced well was returned to production 9/14/94, shut-in on 10/25/94, returned to production 11/11/94 and shut-in again 11/30/94. Amoco has returned this well to production effective 2/13/95.
