

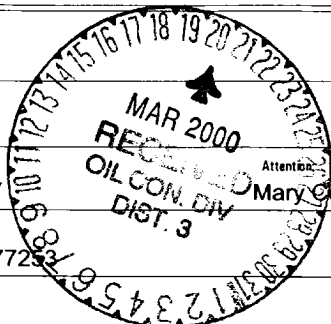

13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. If well is directionally drilled, give subsurface locations and measured and true vertical depths for all markers and zones pertinent to this work.)

Amoco Production Company request approval to plug and abandon the subject well as follows:

1. Notify regulatory agencies (BLM, NMOCD, FIMO) 24 hours in advance of plugging activity. Contact BLM and indicate well is allotted (FIMO regulations effective April 1, 1997).
2. Check location for anchors. Install if necessary. Test anchors.
3. Rigless operation. Blow down well.
4. Bullhead Class B neat cement down casing to abandon PC. Leave top of cement at 2,000'. Wait on cement 3 hours. Perforate squeeze holes at 2,000'. Pump down casing and circulate cement to surface. Use 65:35 POZ and tail in with 100 sacks Class B neat cement leaving casing full of cement.
5. Cut off casing and wellhead. Install PXA marker according to BLM or State requirements.
6. Contact FMC and ship surface equipment to yard or other location per instructions.
7. Provide workorder to Buddy Shaw for reclamation.
8. Rehabilitate location according to BLM or State requirements.
