TD 1578'. Checked TD and circ hole clean. Laid down drill pipe and ran IES log by Welex (Logger's TD 1574'). Ran 51 jts 2-7/8" OD 6.5# J-55 8R EUE new tbq for csg. Cemented w/110 sx BJ 2% Lodense with 1/4# Cello-flake/sk. Recip pipe and had good circ during cementing operations. Circ about 2 bbls cement. Bumped plug w/1200 psi, released to 750 psi, shut-in. TE 1573.81' set @ 1573' GR. POB 2:45 PM 2-7-77.
