Western Mfg spudded 8-3/4" hole at 4:30 P.M., 11-2-80, TD @ 7 P.M., 11-2-80. RU & ran 2 jts 7" 23# N-80 LT&C (84') set at 90'. Cement with 50 sacks Class "B" 3% CaCl₂. Plug down 9:15 P.M., 11-2-80. Circulate cement. WOC 10 hrs*. Test casing 600#. Drill plug & cement. Start drilling 6 1/2" hole at 10:30 A.M., 11-3-80.

*Option 2: Volume of cmt slurry 1.18 cu ft/sack, Class "B" cement + 3% CaCl₂. Approx temp cmt slurry when mixed 60°. Estimated minimum form temp 60°. Estimated cmt strength at time of casing test 555#. Cmt in place 12 hrs prior to test.
