



Dear Mr. Stogner:

By this letter Merrion Oil & Gas Corporation requests administrative approval for a Nonstandard Proration Unit for the Pete No. 1R well in accordance with the provisions of Order No. R-8768, Section No. 5.

The Pete No. 1R was a productive well prior to the existence of the Basin Fruitland pool which was established by Order R-8768 on November 1, 1988. This well is drilled on an Indian Allotted Lease, No. NOO-C-7471, consisting of 160 acres and described as the SE/4 of Section 35, T27N, R12W, San Juan County, New Mexico. The offset acreage to the North is also an Indian Allotted Lease, No. NOO-C-7472, consisting of 160 acres of differing ownership and upon which Fruitland Coal seam production exists from the Da On Pah No. 1 well. Consequently, we have two leases with different ownership. The Pete No. 1R is a much poorer producer than the offset well. Therefore we do not believe it is feasible to communitize the E/2 of Section 35 inasmuch as such an arrangement would be inequitable to the Royalty owners of the lease with the better well.

Merrion has notified, by certified mail, the offsetting operators or lessees of this application and has requested written waivers to be submitted.

Enclosed for your review and approval are a lease map of the affected area along with a C-102 acreage dedication plat for the subject well.
