Purpose:

This well was recompleted into the Pictured Cliffs Horizon. The well is producing large volumes of water from suspected lower Pictured Cliffs Horizon. The well will be repaired by finding the water zone and isolating the water production.

Objectives:

1. Raise Tubing
Return to flowing status
2. Determine water zone
3. Isolate water zone
4. Return to production

Suggested Procedure:

1. Check anchors. MIRUSU. Blow down well. Kill if necessary.
2. Raise tubing to 1570'. RTP with N2.
3. RUHLS. Run Temp & Density Spinner Log
4. Advise engineer to where water zone is
5. If water zone is bottom of PC isolate with a CIBP. If water is coming from top perforations advise engineer. A cement squeeze will be required.
6. TOH with 2 3/8" tubing & Laydown.
7. TIH with 2 1/16" tubing and land mid perforations.
