Spud a 12-1/4" hole on 6-15-85 at 1845 hrs. Drilled to 424'. Set 9-5/8", 36#, K55 casing at 405' and cemented with 325 cu. ft. Class B Portland. Circulated cement to surface. Pressure tested casing to 1000 psi. Drilled an 8-3/4" hole to a TD of 6618' on 6-25-85. Set 7", 23#, K55 casing at 6618'. Stage 1: cemented with 655 cu. ft. Class B and tailed in with 679 cu. ft. Class B. Stage 2: cemented with 1162 cu. ft. Class 3. Ran a temperature survey (attached) which indicated the top of the cement to be at 500'.

The DV tool was set at 3260' and the rig was released on 6-26-85.

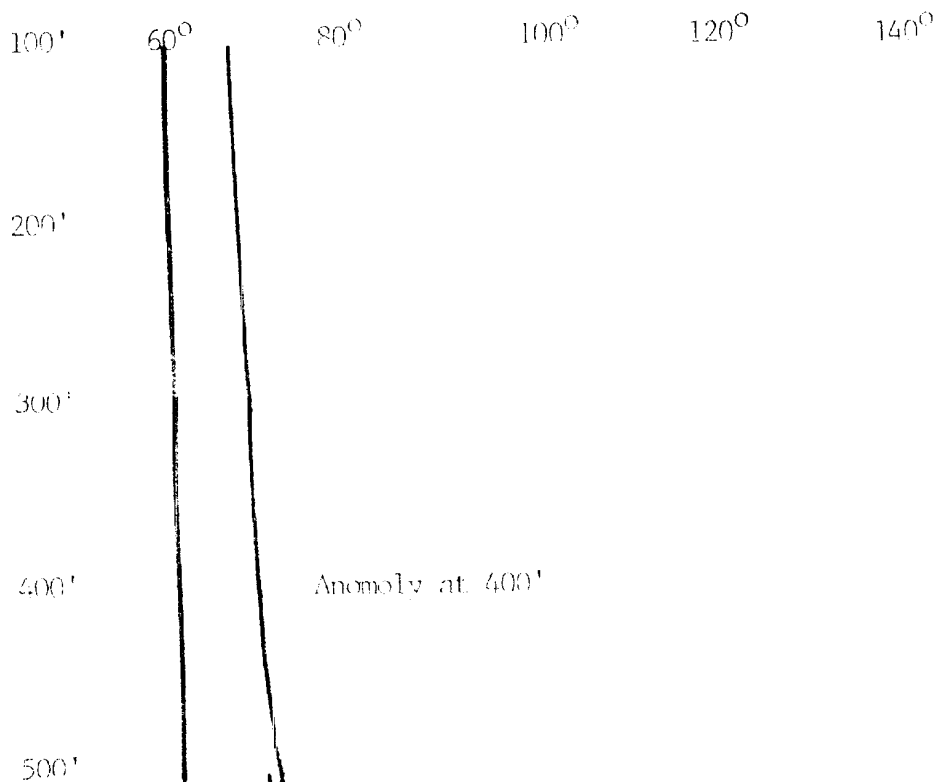
