Class "B" 65/35 Poz, with 6% gel, 2% calcium chloride and 1/2 cu.ft./sack perlite (261 cu.ft.) followed by 100 sks. Class "B" with 2% calcium chloride (118 cu.ft.). WOC 12 hours. Held 1200#/30 min. Top of cement at 1300' by T.S.

9-7-85 TD 5270'. Ran 50 jts. 4 1/2", 10.5#, K-55 casing liner, 2610' set @ 5181'. Float collar set @ 5169'. Top of liner hanger @ 2571'. Cemented with 50 sks. Class "B" 50/50 Poz, 2% gel and 0.6% fluid loss additive (63 cu ft) and 290 sks. Class "B" 50/50 Poz with 2% gel, 6.25# gilsonite, 1/4# flocele, and 0.6% fluid loss additive (393 cu.ft.) WOC 18 hours. Circulated cement to surface.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
