- 5) Perf'd Fruitland Coal 1805', 1814', 1845'-50', 1880'-84' w/2 JSPF on October 3, 1990.
- 6) RIH w/FB packer on 2 3/8" tbg.
- 7) Acidized perfs w/1500 gals NEFE & 38 ball sealers @ 3.5 BPM @ 1600 psig.
- 8) Released packer & knocked off balls & POOH.
- 9) Frac'd formation w/82,800# sand x 56,800 gals of 70 quality nitrogen foam @ 20 BPM @ 1000 psig.
- 10) Flow well to frac tank.
- 11) RIH w/RU. Cleaned out sand to 1906' PBTD.
- 12) Land tbg @ 1803' KB.
- 13) Swab well in. Flow to frac tank.
