An application was filed 3/23/00 with the Navajo Agricultural Products Industry (NAPI) for a pipeline to connect this well. A sundry was filed 3/6/00 with the BLM for this project. Brian Wood with Permits West estimated it would be six to eight months before Louis Dreyfus Natural Gas would receive a response. Louis Dreyfus Natural Gas intends to return this well to production when the permit is approved. Therefore, we request an extension to 12/1/2000.
