Circ between stages, circ 3 bbls flush to DV tool. Cement 2nd stage w/1100 sx Halliburton Lite C + 1/4#/sx flocele. Tail w/50 sx neat cmt + 1/4#/sx celoflake. PD 3:10 PM, 2/27/99. Circ 40 bbls cmt to pit. Release rig. 2/27/99 @ 5:15 pm.
