Elm Ridge Resources plugged and abandoned the Kelly FC #1 as follows: ND wellhead. NU BOP. Pick up 35-joints. TIH w/4-1/2 bit and scrapper to 1105'. TOH. TIH w/ 4-1/2 CIBP set @ 1100'. Pump 19~~8~~ sx cement across the Fruitland zone from 937' to 1100'. Load hole w/water. Pressure test to 500 PSI - okay. Spot 19 sx cement. Displace w/2.7 bbl. TOH to 372'. Establish circulation. Pump 30 sx cement across the OJO Alamo from surface to 372. TOH. ND BOP. Top off cement 3" below surface.
