TXA Procedures
Storey C LS #3

1. Test location for anchors. Install if necessary. Test anchors.
2. MIRUSU. Blow down well. Kill if necessary with water.
3. POOH with 1 1/4" tbg. RIH with RBP and tbg. Set RBP at 2925'. Pull out of RBP and spot 25 sx cement on top.
4. Test casing integrity to 1000#. Roll hole with pkr fluid. (water and 1 gal anhib).
5. Rehabilitate surface according to BLM or state requirements for TXA.
