Reference is made to your application for approval of a 167.26-acre non-standard gas proration unit in the South Blanco-Pictured Cliffs Gas Pool consisting of the following acreage:

Township 28 North, Range 9 West SE/4 (N/2 SE/4 & Lots 3 & 4) of Section 34

It is understood that this unit is to be ascribed to your Storey Well No. 4-C, located 900 feet from the South line and 1090 feet from the East line and in Lot 4 of Section 34, Township 28 North, Range 9 West, NMPM, San Juan County, New Mexico.

Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the Southeast Quarter (SE/4) (or N/2 of SE/4, Lots 3 and 4) of Section 34, Township 28 North, Range 9 West, San Juan County, New Mexico, and in support thereof states the following facts:

- 1. The Storey 4-C Well located 900' from the South line and 1090' from the East line of Section 34, Township 28 North, Range 9 West, was completed as a gas well on December 5, 1956, and has not as yet been connected to El Paso Natural Gas Company's gathering system.
- 2. That the proposed non-standard gas proration unit consists of 167.26 acres which are contiguous quarter sections and lots.
- 3. The proposed non-standard gas proration unit lies wholly within a single governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That El Paso Natural Gas Company either holds operating rights or is sole working interest owner in all the land which lies contiguous to this quarter section in all directions, therefore, it is unnecessary according to the regulations to send out any further letters of notification in regard to this matter other than to the Oil Conservation Commission.

Therefore El Paso Natural Gas Company requests that under the provisions of Rule 6(b) revised of Order No. R-565, the Secretary of the Commission grant exception to Rule 6(a) without notice and hearing and approve the subject non-standard gas proration unit.


