4. Drill from 4500' to TD with natural gas.

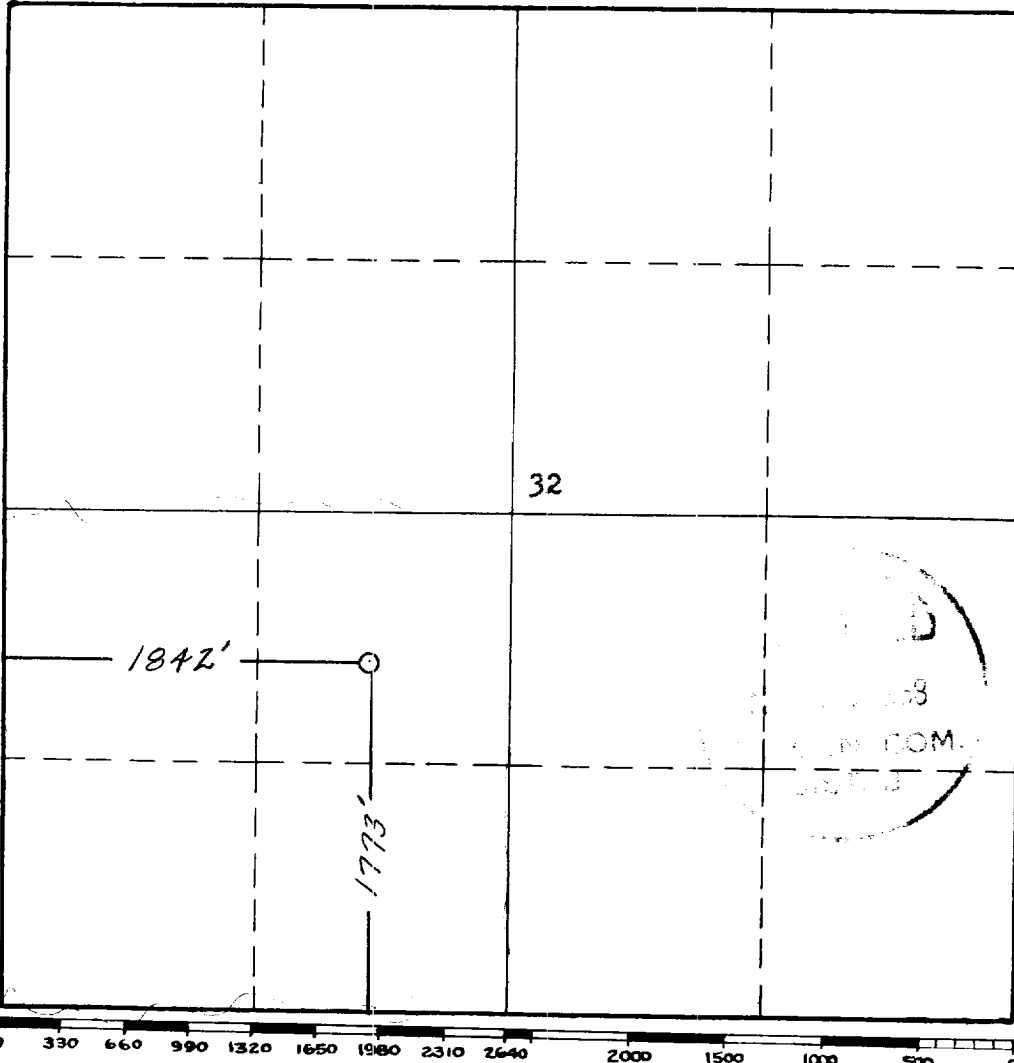
