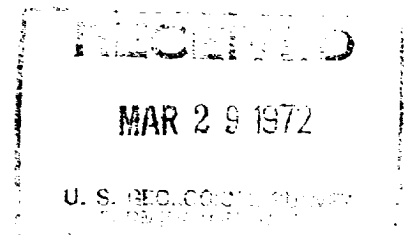

Propose to re-align casing head as follows:

Rig up workover unit, pull 2" tbg., run cast iron bridge plug & set at 6500' to protect Dakota Formation. Load hole w/2" KCL water. test and find hole in csg. squeeze w/350 sx. cement, drill out cement, test csg. to 2000'. If any leaks, re-squeeze, drill out cast iron bridge plug, C.O. to T.M., 6700', land tbg. and swab well off.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
