- 1. Hold safety meeting. MIRU workover unit. If necessary, kill well with a minimum of 1 % KCl. NU BOP and TIH and tag for fill. POOH w/ 1.25" production string.
- 2. If necessary, RIH w/ 5 ½" bit and scraper. RU Power swivel and clean out to PBTD (3050'). POOH w/ bit & scraper.
- 3. RIH w/ production tubing land SN at +/- 3010'.
- 4. Clean location & RDMO workover unit.
- 5. Install &/or hook up any necessary flowline, separation and metering equipment.
- 6. Return well to PC production.
