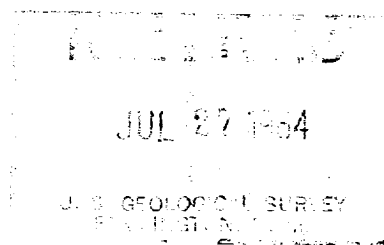
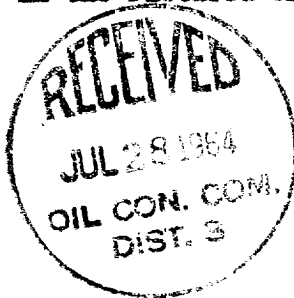

Instructions

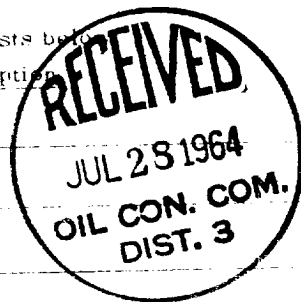

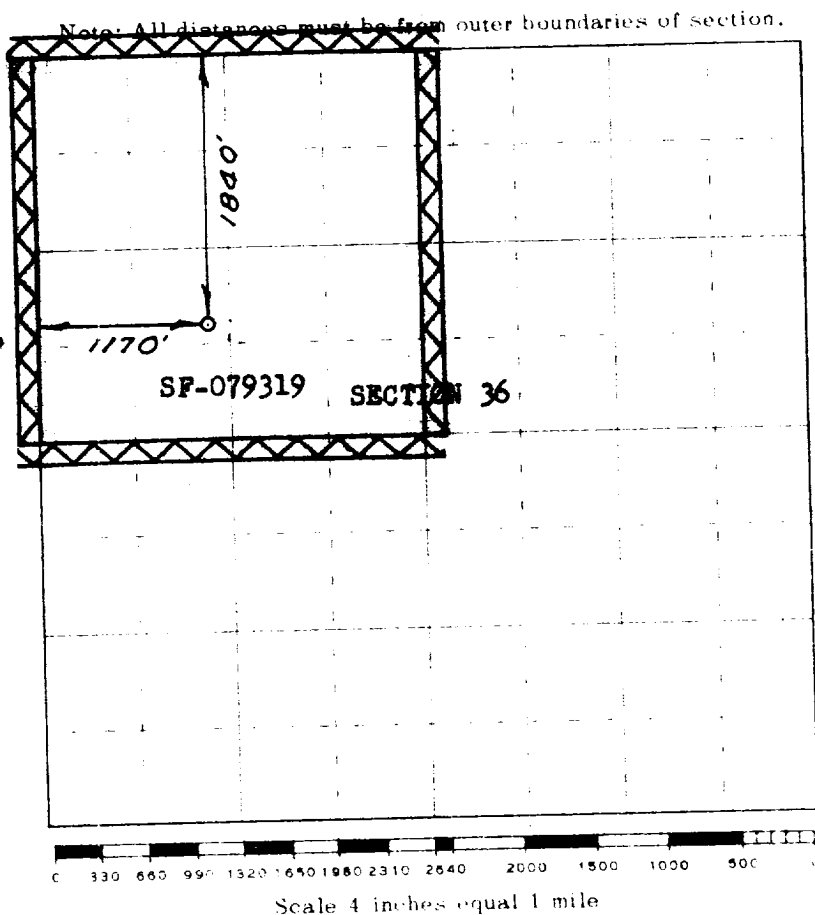
