DETAILS OF WORK

Fred Reesal #11 Well No. 1 was spudded on May 18, 1959, and on May 20, 1959 9-5/8" casing was landed at 436' with 250 sacks cement. After waiting on cement, casing and water shut off were tested with 600 pounds pressure for thirty minutes which held with no drop in pressure. Reduced hole to 8-3/4" at 448' and resumed drilling operations.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
