DETAILS OF WORK

It is intended: (1) to drill a well with rotary tools through the Mesaverde; (2) to drill the pay section with gas circulation; (3) to shoot the entire Mesaverde with two quarts per foot. Total depth 5488'.

Casing Program:

9-5/8" at 150' with cement to surface.

7 " at 4536' with 300 sacks regular cement.

$N\frac{1}{2}$ of Section 33 is dedicated to this well.
