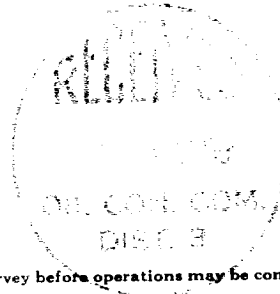

DETAILS OF WORK

J. C. Davidson "P" well No. 1 was spudded on July 26, 1959 and on July 27, 1959 2-5/8" casing was set at 363' with 225 sacks cement containing 2% calcium chloride. Circulated cement. After waiting on cement, casing and water shut off were tested with 800 pounds pressure for thirty minutes, which held with no indication of pressure drop. Reduced hole to 7-7/8" at 363' and continued drilling.
